During the Company's Board of Director meeting on September 19, 2013, the Board of Directors elected Gregory S. Bielli as President and Chief Operating Officer and Director of the Company. Mr. Bielli, who is 53, will replace the Company's current CEO, Robert A. Stine, when Mr. Stine retires at the end of this year. At that time Mr. Bielli will become the President and CEO. Mr. Bielli joined the Company on September 16, 2013.

Mr. Bielli has nearly 25 years of experience in real estate, land acquisitions, development and financing. He comes to Tejon from Newland Communities, one of the nation's largest and most successful master plan community developers. Mr. Bielli was President of Newland's Western Region and was responsible for overseeing management of all operational aspects of Newland's portfolio of master planned commercial and retail real estate projects and communities in the region. Mr. Bielli has worked with Newland Communities since 2006.
